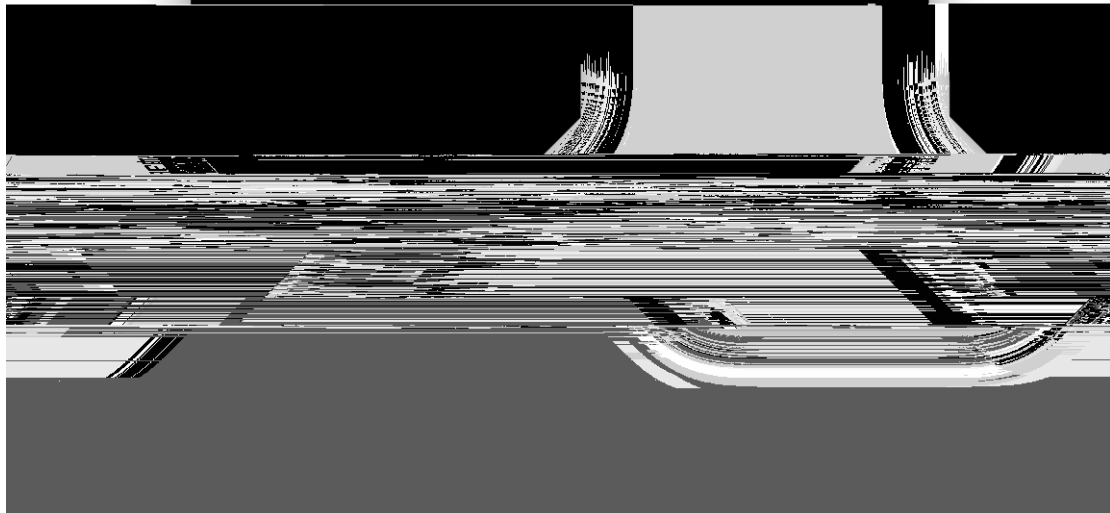
### Background

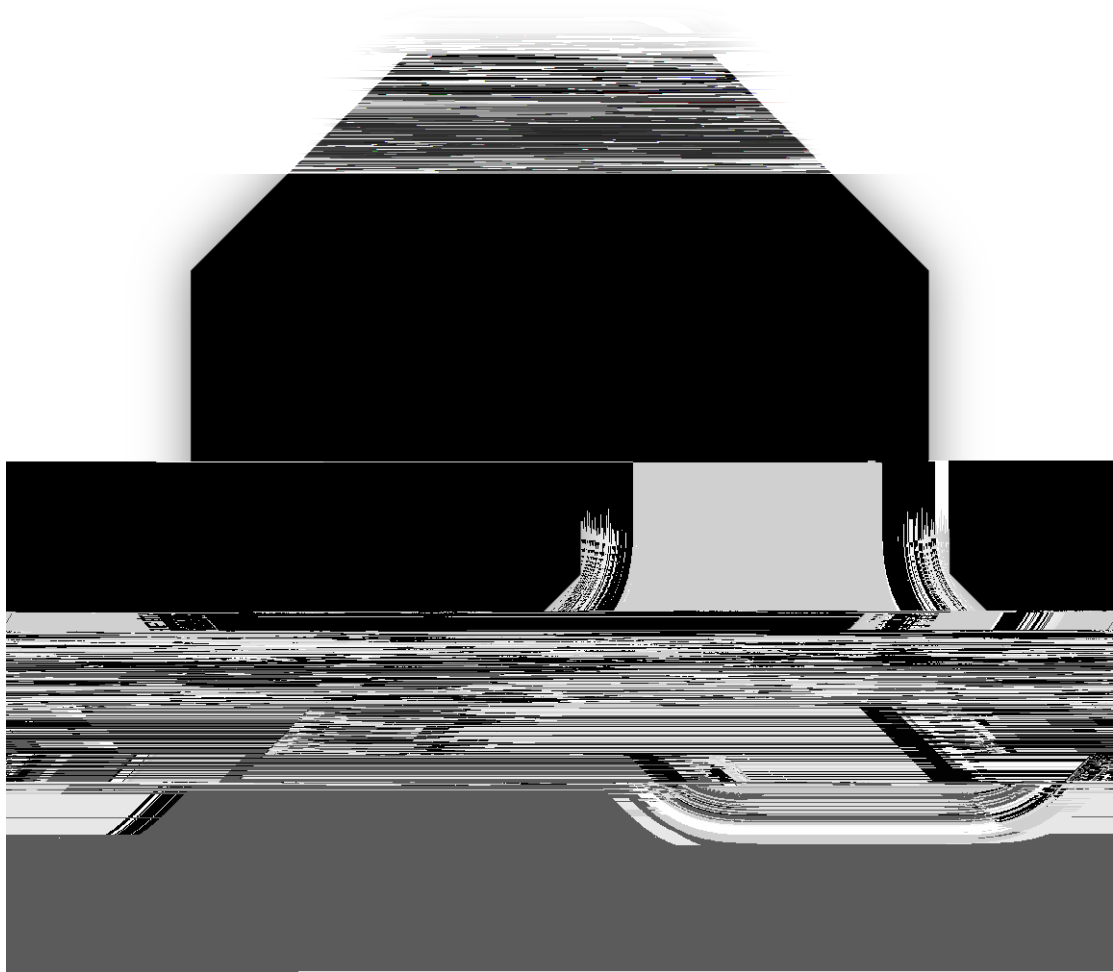

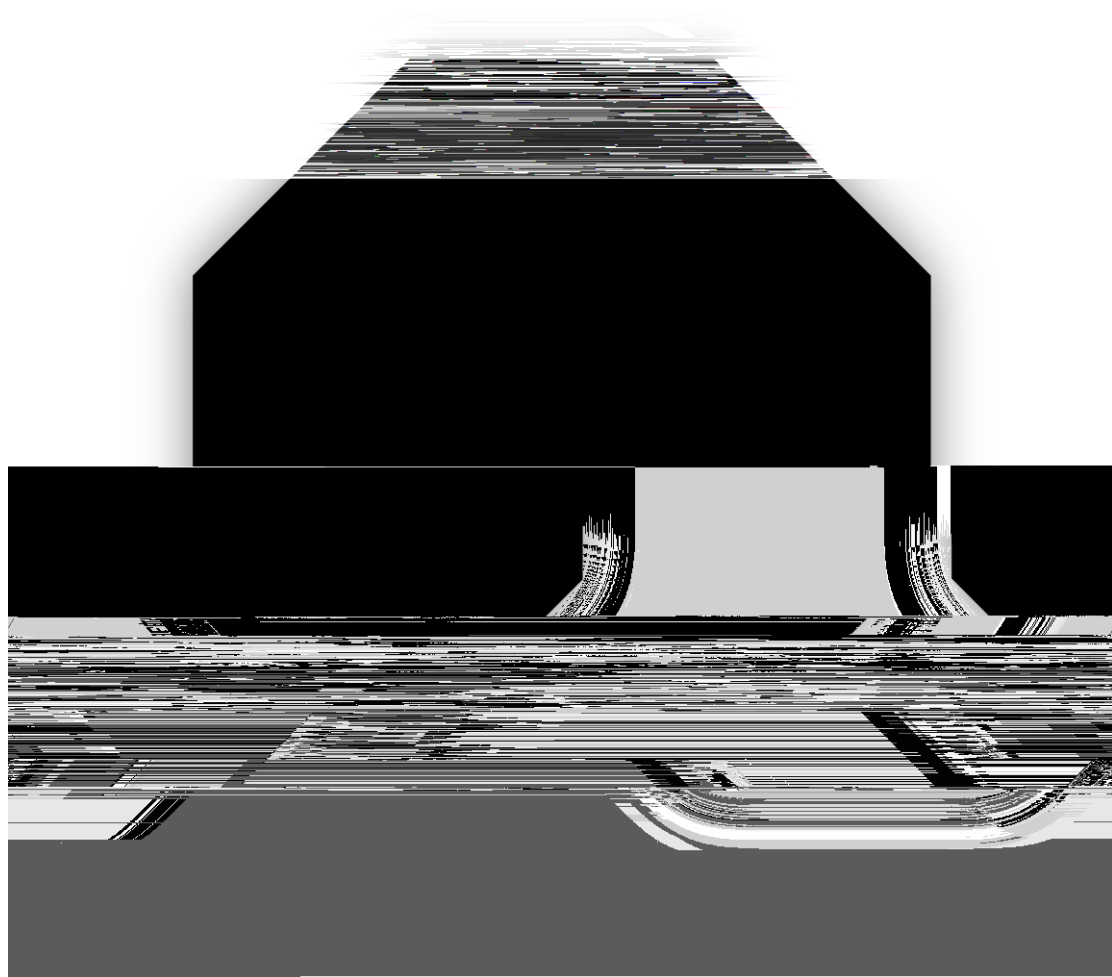
#### Activity data and emission factor compliance
